ACDelco KEY FLEET PROGRAM REGISTRATION FORM

The ACDelco Key Fleet Program (the “Program”) is designed to provide additional benefits to ACDelco fleet customers who purchase ACDelco products to service their own fleet vehicles and fleet equipment. ACDelco Customers that qualify as ACDelco Key Fleet customers will receive access to the following Program benefits:

- Technician Service Training (Hosted Seminars, access to online and virtual training)
- Technical Support Benefits* (See Key Fleet Program Benefit Sheet)
- 5% ACDelco Parts Purchase credit, based on net quarterly purchases, applied to your account, provided the minimum per quarter purchase requirement is satisfied.

The benefits of the Program are designed to increase a fleet’s efficiency and to reduce vehicle downtime and related operating expenses. To qualify as an ACDelco Key Fleet customer you must be a business or governmental unit that owns or leases fifteen (15) or more motor vehicles that are operated to conduct the business of the Fleet Account. Independent Service Centres, Retail Service Centres, Dealers, Jobbers, Warehouse Distributors or any other entities that do not meet the definition are not ACDelco Key Fleet customers and are ineligible to participate in this Program.

To be eligible to participate in the ACDelco Key Fleet Program, you must satisfy the following requirements:

- Be an ACDelco Key Fleet customer, as defined above;
- Service your fleet vehicles/equipment ‘in house’; and
- Purchase a minimum of \$5,250 (before tax and net of returns) in ACDelco products per calendar quarter from an authorized Canadian ACDelco Distributor.
 - Purchases can be made from only one (1) authorized Canadian ACDelco Distributor, who is noted as the program sponsor
 - Purchases outside of the one (1) sponsoring Canadian ACDelco Distributor will not be eligible towards the quarterly purchase minimums and earnback

This enrolment will not circumvent any existing parts procurement contracts. If the ACDelco Key Fleet customer does not meet the \$5,250 quarterly purchase requirement, the 5% credit will not be applied to their account. ACDelco may terminate or modify the ACDelco Key Fleet Program at any time upon 30 days’ written notice. ACDelco Key Fleet customers may withdraw from the Program at any time.
